### **News of Note**

The <u>US Food and Drug Administration</u> (FDA) is allowing marketing of a self-fit hearing device, the Bose Hearing Aid, intended to amplify sounds for individuals 18 years or older with perceived mild to moderate hearing loss, according to a <u>release</u> from the FDA. This is the first hearing aid authorized for marketing by the FDA that enables users to fit, program, and control the hearing aid on their own, without assistance from a healthcare provider. In addition, according to the FDA's news release, when participants self-fit the Bose Hearing Aid, they generally preferred those hearing aid settings over the professionally-selected settings. The Bose Hearing Aid has been labeled to inform the consumer when to consult a hearing health care professional. To read more, go to
